

## Fundraiser mandate

This mandate defines the full mandate of a fund created by the relevant residents of Knoppieslaagte, Mnandi, Timsrand, Monavoni and surrounding areas on Tuesday 27 September 2022. No change to this mandate can be affected unless returned to the community via due process.

This fund will be known as "The case 6379 fund", further referred to in this document as "the fund" or "this fund".

All money raised by this fund will be utilised solely for the purpose of effecting a successful eviction on the properties as defined in the Gauteng High Court case number 002/6379/2022, as well as auxiliary costs to affect the eviction itself as anticipated by case number 002/6379/2022.

This fund seeks to raise the entire cost of an urgent eviction.

Several other avenues are being exploited by the landowners including but not limited to approaching the Office of the President, various Ministerial offices, MEC's, the City of Tshwane and Eskom. These other avenues are not to be limited by the actions of this fund and remain potential for the recovery of funds originating from this fund.

In order to raise the required funds each household in the areas listed above will be requested to contribute a minimum amount of R2000.00. If this cannot be done in one payment, we request a pledge followed by payments of what can be afforded in monthly payments until the amount has been covered. Businesses will be approached requesting additional financial support. Any external financial support will also be welcomed. Appropriate documents and procedure to record all pledges to this fund will be distributed shortly by the administrators of this fund.

Once the eviction has been affected, continuous engagement will be made by the administrators of this fund with parties such as The State, Eskom and landowners to recover as much as possible of the cost from them. Once completed any remaining funds will be distributed to contributors in proportion to their contribution.

The fund's administrators will have the right to obtain short term unsecured finance for the fund to facilitate execution of the fund's mandate.

All funds collected for this fund have to be deposited into the legal trust account of the firm Vermaak Marshall Wellbeloved – Inc.
